Reports

<u>Highway Superintendent</u>, Kris Scullion reports that there was some flood damage, mostly on the dirt roads where the culverts were frozen, and that they are cold patching pot holes and ordering culverts. He also asked the board to consider a wood stove at the Town Barn.

On a motion by Councilman Schadt, seconded by Councilman Kuebler to allow the Highway Superintendent to solicit bids/proposals per our procurement policy, for a wood stove at the Town Barn. Motion Passed - 5 Ayes

<u>Code Enforcement Officer</u>, Kevin Zieres reports a quiet month for the Building Department, although he is seeing interest in building for the spring. A discussion about the garbage at SBL # 19.-6-1, concluded that a notice will be sent to the owner and if the garbage is not cleaned up by March 25, 2011, the Town will clean it up and it will be levied on the tax bill.
