<u>Highway Superintendent</u>, Kris Scullion reports that the Town of Callicoon Clean up held on May 4, 5, 6, & 7 went well. They had 9 dumpsters @ \$160.00 each, totaling \$1,440.00. We tipped 36.84 tons and we had 6.058 tons of metal which we hauled and we should receive about \$1,363.05. Besides that we have been ditching and changing pipes for roads to be paved.

Councilman Schadt Thanked the Highway guys for a great job.

They discussed the NYSEG job # for the bridge project in Callicoon Center, we are coordinating all involved and shooting for three days at the end of June. They discussed notifying the Control Center.

<u>Code Enforcement Officer</u>, Kevin Zieres reports that we are getting quite a few building permits, it is that time of year. He also reports that they have no continuing education this month, but there are some scheduled for the next couple of months. He noted that the Planning Board approved a used car lot in Youngsville.

The Supervisor reported that the Clean up went well and mentioned the steel that was brought. He also thanked the County for the Clean up. He also read a cost of Clean up look back from 2002 - 2011. (See attached.)

The Supervisor noted that the board had accepted the nomination of Frieda Pericho, and although Frieda was not able to attend he showed the audience the plaque she will be receiving.

A proposed local law for the logging permits was received by the Town Attorney for the board to review.

Councilman Schadt thanked the committee for the work done on the Comprehensive Plan.

The Deputy Supervisor thanked the public who attended the public workshop.

Public comments included a Thank - you to the highway crew for the clean up, and comments regarding the Veterans Memorial included design, information statements, proposed procedural plan, making information statements available to Janet as official statements, contacting the art department at the SWCSD for students to draw design of memorial, volunteers, site/location of the memorial, lighting, maintenance, builder, engraver, funding, a dedication date, and the memorial in front of the Roscoe Firehouse. A resident also asked if the logging resolution will be on line, and if there was a target date for the responses of the public comments of the comprehensive plan.
