Councilman Kuebler addressed the flooding situation and the bridge in Youngsville, they had met with the head engineer of NYSDOT, the bridge is structurally good but it has that concrete bottom.

Supervisor Bose stated that he met with the DEC and they have agreed to do a fly over, he also states that the DEC and the DOT have been cooperative but there is a lack of funding. Discussions included a trash trap, State DOT standby when flooding, private property issue, repairs by homeowners, NRCS involved, money allocated by John Bonacic's office, Aileen Gunther's office involved, investing in property means maintenance, the DOT commitment to keep gravel removed, and a Thanks to residents for their patience.

Assistant Code Enforcement Officer, Gregg Semenetz reported that they are working on the cell tower in Youngsville and the one on Mueller Road in the Town of Bethel. They should be done by the end of the year.

Open Floor

Open Floor comments included the Veterans Memorial Update, flooding issues, problems with the Adult Home residents, and NRCS (Natural Resource Conservation Service) definition.
