Supervisor Bose called the meeting to order with the Pledge to the Flag at 7 pm. The published Legal Notice was produced.

The Joint Work Shop is being held to discuss ideas and concerns about Small Businesses in the Town of Callicoon & The Village of Jeffersonville.

Allen Scott was present from Sullivan Industrial Development Agency. Discussions included the purpose of the IDA, new business projects, existing businesses looking to expand, options the IDA has to offer, major obstacles with businesses in Sullivan County, training the workforce, facilitating a consortium of businesses, high speed internet service, internship programs, business plans, changing IDA criteria, promoting the area, and a calendar of events.
