### **Reports**

<u>Highway Superintendent</u>, Kris Scullion reports that the Town Clean up and the Litter Pluck went well. The money from the metal covered the hauling charge. He also mentioned the labor positions and the park update that will be covered on the agenda. He noted that the new truck is at Tracey for warranty work, they have been patching and changing pipes, and the Black Top Plant is now open. The Supervisor agreed that the clean up went well and Thanked all the volunteers who helped with the Litter Pluck.

<u>Code Enforcement Officer</u>, Kevin Zieres reports that permits are up, there's a new house going up on Grabel Road. He also noted that he has a situation of a absentee landlord in North Branch and may need to ask the board about a forced clean up.

#### **Business Items**

David Bodenstein, representing Mike Preis Insurance, was here to present the Insurance Proposal. He went over the proposal page by page. The board will address this at the June meeting so they have time to review the proposal. The new security system for the Town Barn was mentioned to the agent as a possible reduction. The Supervisor will let him know when the system is installed.

On a motion by Councilman Gaebel, seconded by Councilman Kuebler to accept the only bid for the pipes as read. Motion Passed - 5 Ayes. (See attached bid).

On a motion by Councilman Kuebler, seconded by Councilman Schadt to allow the creation of two (2) temporary Laborer Positions for the Highway Department. Motion Passed - 5 Ayes.

On a motion by Councilman Fuchs, seconded by Councilman Kuebler to allow advertisement of the temporary Laborer Positions for the Highway Department. Motion Passed - 5 Ayes. This advertisement will also go on the web site.

The update on the Town of Callicoon Town Park included, the pump is in and the well is complete, the plumbing and heating is almost completed, when things dry up they will start the septic and grade up. It has been noticed that people are using the park to walk there dogs, which was not the plan, if anyone sees those walking dogs-make sure they clean up after themselves. They figure the park will be usable by early June. They also mentioned signs in the future and hopefully finishing the kitchen next year.
