REPORTS

Highway Superintendent, Kris Scullion reports that things are very busy lately. He reports that he spoke with Dave Bloodgood from NYMIR and when they came to inspect they found nothing and the report was good. He also spoke with Verizon in regard to the Earl Myers Bridge project and the Verizon cables. Once the Town gets proposals for the Crane Operator he will meet with Verizon and the Crane Operator. The Supervisor addressed the Agenda item to advertise for the culvert for the bridge project and noted that Joe Anne and Kris have been busy working on the SAM Grant through Senator Bonacic's Office for the bridge. A discussion followed in regard to Kris Scullion flying to Charlotte, NC to look at a new Chassis to replace the 2012 truck and the payment from the AAR Auction Company. Tom spoke to the Company and they have mailed the check.

<u>Code Enforcement Officer</u>, Kevin Zieres reports that there are not many permits this time of year. He noted that he is working on an unsafe building which will be in Court tomorrow night. He also states that even the Planning Board has been very quiet all year. Deputy Code Enforcement Officer, Gregg Semenetz reported that they will be attending a Code class next Thursday.

The Supervisor recognized Michael Chojnicki who is here to talk about Community Choice Aggregation. He asked if the Town received the email about Community Choice Aggregation which the Town did not receive. Councilman Schadt noted that the Liberty Elks will be donating \$400.00 to the Veteran's Memorial Project.

Councilman Gaebel advised that the Saturday Basketball Program went well and they only have one week left.

The Supervisor reported that they are holding a partial payment of the money owed to the Little Tykes Playground Equipment Company due to the fact that the Highway Department spent time installing the equipment, supplied the backhoe for the installation and there was damage to a lid by Little Tykes which was covered with a cone. The Town has contacted Little Tykes and sent an itemized list of hours and the repair.
