Kris noted that the job went well, they had received the permit, through Brian Brustman with Soil & Water, and the weather was great. He also reported that they are now just getting ready for the Fall Clean Up and making frames for the Right to Farm signs that Howard made.

Supervisor Bose noted that it was a pleasure to see the bridge work on Earl Myers Road completed in one week and thanked Kris and the highway guys. Councilman Fuchs agreed.

<u>Code Enforcement Officer</u>, Kevin Zieres reports that he writing quite a few permits but nothing major.

Supervisor Bose addressed the property on the Callicoon Center end of Hust Road. The property was purchased through the County Auction and he is hoping the new owner will clean it up, he also added that maybe the new owner will take advantage of the Town Clean Up.
