Supervisor Bose called the meeting to order with the pledge to the flag at 3:30 p.m.

This Special meeting is being held for the purpose of the Town Clerk to present the Town of Callicoon Town Board the 2022 Tentative Budget and anything else that comes before the Board.

The Budget Officer went over the budget line by line.

**RES#10-2021**, on a motion by Councilman Kuebler, seconded by Councilman Schadt to approve the rate increase for the Insurance Buy Out amounts from \$2,000.00 to \$3000.00 annually for an Individual policy and from \$3,500.00 to \$5,000.00 annually for a Family, Employee and Spouse, or Employee with Children policy.
