REPORTS

<u>Highway Superintendent</u>, Mike Haff reports that the 6' culvert replacement on Hardenburg Road is completed, they did receive the new truck, and they have been working on routine maintenance on the roads, however with the heavy rains there has been some extra maintenance. Mike reports that he spoke to Callanan regarding additional paving and started receiving sand from Deckelman for the winter.

Supervisor Bose advised the public that the project on Hardenburg Road came in under budget, he stated they did a good job and thanked all those involved with the project. He added that Mike had coordinated with the Sullivan County DPW to install the guard rails since they have the machine to do it and the Town should get about 90% back through Soil & Water for the project.

<u>Code Enforcement Officer</u>, Kris Scullion reports that he has been busy, there were three new applications for new houses last month and there is two for this month. He did add though that there have been a lot of complaints. The Supervisor asked Peter Lorenzo from the Callicoon Center Fire Department if there was anything to report on the building over the creek in Callicoon Center to which Peter said no. Kris has reached out to the President, Mike Sorge, of the Callicoon Center Fire Department but he has not gotten back to him.

The Supervisor advised the public that due to increases in maintenance, trucks, parts, and paving there may be an increase in the budget. He also mentioned that the State mandates a two percent limit on increase to the tax levy in the Town's budget and he stated that the State should be held to a similar limit on spending.

On a motion by Councilman Gaebel, seconded by Councilman Hubert to approve the Agreement of the Annual Contract between the Jeffersonville Volunteer First Aid Corps and the Town of Callicoon for a period of one year in the apportioned amount of \$204,407.89 for the Town of Callicoon.

The Supervisor reminded the public that the Fall Clean Up will be held on Friday, September 22, 2023, and Saturday, September 23, 2023, from 8:00am to 5:00pm. The Shred Day, co-hosted by the Town of Callicoon and Jeff Bank will be held on Saturday, September 23, 2023, from 9:30am to 12:00pm. The Supervisor thanked Jeff Bank for co-sponsoring the Shred Day and stressed that there will be absolutely "No Dumping on Sunday, September 24, 2023."
