#### **REPORTS**

Highway Superintendent, Ryan Bose was running late due to checking the roads due to the rain so Supervisor Bose noted that they will be starting to pave at the end of the week if we do not get heavy rain. They have been patching and are ditching on Stump Pond Road. They are mowing the roads. Ryan reports that there is a road closure at the Fremont end of Buck Brook Road. He reports that they received the new loader, and the old loader is listed on the Absolute Auction Realty site. The Volvo Grader is in protection mode because of engine emission problems. Ryan noted that after Fremont is done, they will start paving on Schaefer Road and Tonies Road and then move to Hahn Road.

Supervisor Bose thanked the Highway Department for applying the approved mulch at the playground at the Town Park. He also noted that Derek Hahn pressure washed the pavilion, and he is going to give an estimate on pressure washing at the Town Hall. Supervisor Bose noted that he is waiting for a proposal for the installation of hand dryers in the bathrooms at the Town Park from Gary Peters.

<u>Code Enforcement Officer</u>, Kris Scullion, was absent.

#### **Business items**

Supervisor Bose introduced Eric Michelitsch from Delaware Engineering and Kevin Klein, the Water Superintendent who were present to give an update on the water tank project. Eric noted that the foundation and the new tank were installed and after the cleaning and the disinfecting the next phase is filling and testing. Once the new tank is in service then the old tank will be demolished. Eric advised of a change order for the new electrical shed where the electronics and controls will be replaced as needed with no interruption of service from the existing shed to the new shed. Further discussed was the project is within the budget, the old tank cannot be used as backup as per the Department of Health, using the water from the old tank, routine tank inspections, close out documents, electronic mixer in the new tank, bricks,

anodes, and the grant funding deadline. Eric asked for the Town Board's approval of change order #3 and the payment approval #6.
