Supervisor Bose called the meeting to order with the Pledge to the Flag at 7:30PM.

On a motion by Councilman Schadt, seconded by Councilman Hubert to accept the minutes of the September 8, 2025, Regular Town Board Meeting. Motion Passed – 5 Ayes.

On a motion by Councilwoman Rasmussen, seconded by Councilman Gaebel to accept the minutes of the October 1, 2025, Special Town Board Meeting. Motion Passed – 5 Ayes.

Supervisor Bose asked the Bookkeeper to run the numbers and advised the public that the interest received through NY Class for General A alone is \$43,193.04.

REPORTS

<u>Highway Superintendent</u>, Ryan Bose reports that the Clean Up was slower than usual but went well. It will be discussed as an agenda item. Ryan noted that they will be ditching on the dirt roads, they have been clearing trees on Bethlehem Road where they used the grader to smooth it out since next year they will have to plow since a new house is being built. They have been using the grader on Gorr Road and Deunher Hill Roads and touching up on the dirt roads. Ryan advised the Town Board that he received sand from Aden that had clumps and was not washed, and he tried Jen Rutledge and had the same issue with the sand. Ryan stated that we are getting the sand from Callanan. Councilman Schadt asked if it was the brown sand or the grey sand.

Ryan read aloud the proposals for the new truck. Each company that submitted proposals were all members of Sourcewell which is equivalent to State Bid which allows the Town to get proposals rather than put it out for Bid.

Proposal #1-International from Arkel Motors - \$149,873.00

Proposal #2-Peterbuilt from Dimmick Group Peterbilt - \$181,808.00

Proposal #3-Freightliner from Campbell Freightliner of Orange County LLC-\$143,354.00 Ryan advised the Town Board that the 2017 body from the 2006 International truck will be transferred to the new truck with the hydraulics. A new plow with frame will be installed. Ryan stated that they are going to use the 2006 truck through the winter and switch the body over to the new truck after the new year, however the truck has electrical issues and motor issues, but he is hoping it makes it through the winter.

Based on the suggested opinion of the Highway Superintendent, a motion by Councilman Schadt, seconded by Councilman Hubert the motion to purchase the new international Chassis from Arkel Motors in the amount of \$149,873.05. Motion Passed – 5 Ayes.

Code Enforcement Officer, Kris Scullion reports that he has the site plan for up on Bethlehem Road that Ryan, the Highway Superintendent, had referred to in his report. Kris added that there may be a three-lot subdivision on the other side of the road so the Town will have to plow there now. Kris reports the things are all good, they have over 100 permits for this year. Kris advised the Town Board that the York-Wood in North Branch has been sold, and the new owner is working on a plan. Supervisor Bose stated that he, Kris Scullion, and Councilman Schadt met with Mr. Roth the owner of the Shandelee Lake Inn and they met with the Engineer to address everyone's concerns about the property. Mr. Roth stated that he wants to be a good neighbor and has no intention of running an air bnb or a Short-Term Residential Rental, he has just kept the hotel status for the quarterly taxes for resale. They explained to Mr. Roth that the hotel status was no longer in place as the time frame has run out and it is now under a single-family house status. They also discussed the pool, and Mr. Roth was aware that the pool had to be repaired. Also discussed were the trees and shrubs, and the water meter which is working as the engineer who was present at the meeting stated. It was decided that at this point to see what happens next year.
